TUTION FEE REFUNDS

Before applying, please ensure that you have read the LEA Course Modification and Tuition Fee Refund Policy and Procedure Policies And Procedures | lincolnau.nsw.edu.au and understood the Procedure, to determine your eligibility for a refund.

The tuition fee refund amounts can be full, or partial or no refund dependent on the circumstances or reasons for withdrawal and the time of withdrawal as compared to the start of the course or census date. Refunds will be paid:

- To the person or entity from whom the original payment was received.
- In Australian dollars and all refunds incur a \$150.00 processing fee.
- To the same account or credit card from which the original payment was made at the time of enrolment.
- Within four (4) weeks of receiving a refund claim by LEA, provided all the banking information for payment of refund is also received on the application.

Refund payments will only be calculated and processed based on LEA's tuition fees.
